

# SUMMER CAMP ENROLLMENT AGREEMENT

1. I understand the summer registration fee is non-refundable, not applicable to tuition and is payable for each summer camp.

2. I hereby agree to pay tuition prior to attendance, for each month or week, by check or money order (cash will not be accepted).

3. I understand that tuition will be charged weekly and billed for each month.

- ▢ For current Sunshine families, current billing policies and due dates will remain in effect. However, June and August will include both a combination of afterschool and summercamp rates.
- ▢ For new Sunshine families tuition will be due as follows: Tuition is due no later than June 1 or the first day of attendance (early bird due date May 29). July payment is due no later than July 1 or the first day of attendance that month (early bird due date June 19). August tuition will be due no later than August 1 or the first day of attendance that month (early bird due date July 17).

4. I understand that I am responsible for payment for the weeks that I have signed up for. If you will be canceling a week of camp, it must be done PRIOR TO THE DEADLINE (see the cost form for details). The deadline for June 15 thru July 6 is Friday, May 22. The deadline for July 13 thru August 3 is Friday, June 26. After this date, if you have not cancelled any weeks, you will be charged for each week you reserved regardless if you attend or not.

5. I understand that if my child remains at Sunshine past the scheduled closing, I will be charged, and I agree to pay \$1.00 for each minute per child, after closing. Payment is due immediately. Any more than three late pick-ups may be cause for termination from the program.

6. I understand that if the Sunshine staff is unsuccessful in contacting any authorized person(s) to pick up my child one hour after closing, the Department of Children's Services will be called to pick up my child.

7. I understand both a \$25.00 returned check charge and a \$25 late payment fee will be charged for each returned check and agree to pay this fee within one week of notification. I understand that after two checks have been returned, I will be required to pay all fees by money order or cashier's check each month thereafter.

8. I understand I must sign my child in and out of Sunshine's Program daily and that I may be subject to a \$25 fine if I fail to do so. I understand that Sunshine is not responsible for my child until signed in. Should I wish to have my child released to another adult, I will send my written authorization. This adult will be required to show photo identification.

9. I realize children attending the Sunshine Program will be required to follow all program rules. Students may be expelled from the program for failure to meet behavioral expectations. I further realize that I as a parent may be removed from the program for failure to follow all Sunshine policies and procedures.
